COURSE DESCRIPTION: This course is designed primarily for graduate students at the masters and doctoral levels in anthropology and related departments. We begin in the middle of the story, in the mid-19th century, and cover the period until (roughly) 1970, with special attention to the sociological/ethnological methods characteristic of the British, French, German, and U.S. Schools. We cover evolutionary anthropology and its critiques, Boasian historical particularism, British functionalism, the Manchester School, and structuralism. Particular attention will be paid to the work done by Black, Indigenous and women anthropologists, and to the development of national trajectories of anthropology outside of Europe and the U.S. Along the way, we attend to the role of anthropologists in upholding, and challenging, national and imperial projects.
